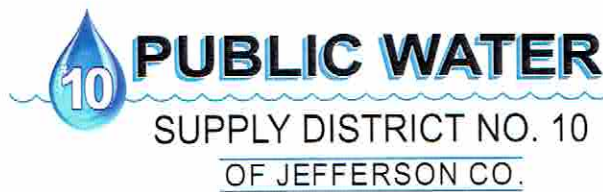

During the Second Quarter of this year (April 1st, 2024- June 30th, 2024) Water District No. 10 did the Stage 2 Disinfectant Byproduct Monitoring for The Missouri Department of Natural Resources at our designated areas. The district collected samples on 05/22/24 and dropped them off at the designated area for FEDEX to pick up and deliver to The Missouri Department of Natural Resources in Jefferson City Missouri. **FEDEX did not pick up or lost.** The samples will be re-tested in August of 2024. There is nothing you need to do at this time. The water is safe to drink.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER **JEFFERSON COUNTY PWSD 10 Failure to Meet Stage 2 Disinfectant Byproduct Monitoring Requirements for Drinking Water**
